## Conditions of Permit

1. Only Valid driver's license holders may operate their motorized golf cart, Class 2 ATV/UTV on City Streets.
2. Motorized golf carts, Class 2 ATV's/UTV's may be operated within the city on public roadways and **must not** be operated on State Trunk Highways, unless the road or highway is under the city's jurisdiction through the issuance of a permit or approval to the city from the county or the Minnesota Department of Transportation and the cart is listed on the community event permit issued by the city. The operator may make a direct crossing of any intersecting roadways. Operators must exercise all due care to avoid travel on roadways with a high frequency of automobile usage.
3. Motorized golf carts, Class 2 ATV's/UTV's may only be operated on designated roadways and intersections from **sunrise to sunset**. If motorized golf cart, class 2 ATV/UTV is equipped with original equipment headlights, taillights, and rear-facing brake lights, they may travel on the designated roadways from **sunrise to 10:00 p.m.** No Motorized Golf Carts, Class 2 All-Terrain Vehicles or Utility Task Vehicles shall be operated in inclement weather or when visibility is impaired by weather, smoke, fog or other conditions, or at any time when there is insufficient light to clearly see persons and vehicles on the roadway at a distance of 500 feet.
4. Motorized golf carts shall display the **slow-moving vehicle emblem** provided in Minnesota Statutes Section 169.522, when operated on designated roadways.
5. Motorized golf carts shall always be operated as close to the right-hand curb as possible, except when the driver is making a left-hand turn. Class 2 ATV/UTV's shall travel in the appropriate lane on designated roadways.
6. No person shall operate a motorized golf cart, Class 2 ATV/UTV on a public sidewalk or trail unless otherwise authorized by the city.
7. The number of occupants in the motorized golf cart, Class 2 ATV/UTV shall not exceed the designated occupant load. Each occupant must be seated in a seat designed for occupants. ATV/UTV occupants must always wear seatbelts on roadways.
8. All operator permits shall be issued for a specific motorized golf cart, Class 2 ATV or UTV. A current city-issued operator's permit tag shall be plainly visible from the front/driver's side of the motorized golf cart, Class 2 ATV/ UTV.
9. Every motorized golf cart, Class 2 ATV/UTV operator must have proof of insurance in possession while operating on designated streets and shall produce such proof of insurance on demand of a police officer as specified in Minnesota Statutes Section 169.791
10. Every Class 2 ATV/UTV operator and passenger under the age of 18 must be wearing a helmet.
11. The motorized golf cart, Class 2 ATV/UTV is in good working condition and safe for the transportation of passengers.
12. This permit expires on December 31<sup>st</sup> of each year.
